
To everyone who picks up trash in the neighborhood! It keeps blowing in and you keep picking it up- over and over again. Someone notices you and what you are doing!

The short-term rentals are supposed to end in December, although there are lawsuits fighting this right now. There is a city park going in near Forest/Audelia. It's supposed to have a library/rec-center all in one building along with parks and trails. The best part is that there should be a storefront for the Dallas Police Department.



Beautification Report---September 2023

It has been a difficult summer for all gardeners here in the DFW area. Not only have we had numerous record setting high temperatures but add to that the only rainfall we have received in June-Aug was a scant fraction of an inch back in mid June. We have struggled to keep the RPE entrance from dying on us and likewise with the new areas at the Claymore bridge over the creek (drainage ditch). We finally got the sprinkler systems at the bridge to work properly after replacing both control boxes and repairing three broken heads. Because of the continued heat you will still see us doing additional hand watering many mornings. Your dues make the repair materials and plants possible and volunteer labor does the dirty hands work just like the replacement of the bridge fences earlier in the year. Thanks for supporting the RPENA by paying \$110 each year. Without your membership dues we would not have money for such repairs. We would not have 4 spot lights illuminating the two trees at our Claymore entrance nor the 2 spot lights illuminating our RPE sign. How many neighborhoods have such lighting at their entrance?

This scorching summer has also been hard on trees, shrubbery and foundations. If you have not been watering your yard twice a week you may have done serious damage to your trees, shrubbery and worst of all your foundation. An article in the Aug 30 edition of the Dallas Morning News went into this issue in detail starting on page B1.

Trash and litter in our yards and streets make for an ugly look when we walk our dog throughout our RPE neighborhood. Sam and I have three routes that we walk every week picking up this ugliness and will frequently fill an entire grocery bag on one walk alone. On Monday, Aug 28 we walked the route that circles our U shaped block: walking Claymore, Harkness, Fall Manor, Burnham, Harkness and back down Claymore to our home. Among other things we picked up 17 plastic bottles, 2 plastic hangars and I wire hangar. This collection did not fit in a single grocery bag. All this had accumulated since the previous cleaning a week earlier. Think about it. What would our neighborhood look like if no one picked up this trash? Thankfully we have folks who love RPE and are willing to stoop down and pick-up this filth to help keep RPE **BEAUTIFUL**.

This year we have tried to honor yards which have never been recognized in recent years. In July we honored another outstanding yard at 9950 Burnham. Tom Clark has been a resident of RPE since 1989 and this year had a beautiful yard in the spring. By the time we put the sign up in mid July, it was looking a little sad just as most of us were losing the battle with the summer heat. We found no other first time yard worthy of honors for the month of August. Let's hope for a more normal summer next year. Halloween is around the corner and we plan to honor a number of yards, so start planning.

Once we get back to more normal temperatures you might plant a bunch of petunias which will give us splashes of color up until the first frost. It looks like that cool down will not come until late September this year.
