SHORT TERM RENTALS STIR DEBATE


An appellate court panel in Dallas heard arguments Wednesday to decide if it needs to lift a temporary injunction on the city's new regulations against short-term rentals in single-family neighborhoods. At issue is a legal fight between property rights and community rights that is likely to continue for the next few months after the City Council voted to tighten zoning and registration regulations that govern properties rented out for less than 30 days.

In court documents, city officials argued short-term rentals drive up housing prices as they eat into the city's limited housing stock and risk changing the character of a neighborhood. Short-term renters don't join little leagues or the nearby schools, said Andrew Spaniol, a city attorney. "They don't look out for elderly neighbors; they don't watch their neighbor's children," he said.





The Great Pumpkin

Ingredients

- 2 ounces pumpkin ale (such as Southampton)
- 1 ounce Laird's bonded apple brandy
- 1 ounce Rittenhouse bonded rye
- 1/2 ounce grade B maple syrup
- 1 whole egg

Garnish: nutmeg, freshly grated

Steps

- 1. Add the pumpkin ale, apple brandy, rye, maple syrup and whole egg into a shaker and dry-shake (without ice) vigorously.
- 2. Add ice and shake again until well-chilled
- **3.** Strain into a chilled Fizz glass.
