CURBSIDE VERSUS ALLEY TRASH COLLECTION

In June 2024, the Department of Sanitation Services briefed the City Council on garbage and recycling collection routing, highlighting safety and operational concerns related to alleyway service. Common challenges with alley collection include limited right-of-way and pavement width, obstructions from overhead utilities and gas meters, and restrictions on the type of waste collection equipment that can be used safely and effectively.

Since that briefing, Sanitation evaluated four potential service scenarios to address these issues, ultimately identifying a path forward known as the staff hybrid approach. Because collection location (alley vs. curb) falls under operational authority, formal Council approval is not required to implement this transition. However, two related items may be brought back to Council for action at a later date:

Update: As of this publishing, our neighborhood is likely to be exempted from switching to curbside pickup. 

HEALTH UPDATE—WEST NILE VIRUS IN 75243

Yes, West Nile Virus is present in Dallas County, which includes zip code 75243, in 2025. The good news is that the samples coming in report low incidence of positive viral particles for our zip code. However, that doesn't mean the chances of contracting the disease is not zero.

Symptoms:

Most people (about 80%) infected with WNV do not develop any symptoms. About 20% may experience symptoms like fever, headache, body aches, and joint pain

However, this is not the case in other parts of Texas. Be aware and take appropriate precautions for summer travel. Following a significant outbreak in 2024, the first confirmed case of West Nile virus illness was reported on June 24, 2025, in a resident of Brazos County, Texas.


This Texas Department of State Health Services (DSHS) announcement raises concerns for all Texans as virus-carrying mosquitoes remain active into December 2025. The most effective precaution is "Deet". All day every day when planning outside activity.

There were 455 cases of West Nile disease in Texas in 2024 and 56 related fatalities.

BEAUTIFICATION REPORT BY CINDY AND JOE GAUTREAUX

Feng Shui - From a Non-Expert!

No, I'm not an expert in Feng Shui, but there are a few things I've learned (and practice) from these principles. The one I'm focusing on for this month's article involves the entry to our homes. For most of us, this means the alley entrance to our driveway and garage. We tend to focus our resources and energy on the front of our homes even though as homeowners in RPE, most of us enter via the rear entry. After a quick introduction to Feng Shui several years ago, I learned the importance of what we see and how we feel when we enter our homes.



This is what Joe and I created. The tall plant with red blooms is "Texas Star Hibiscus"; I have seeds to share if you are interested. This is a sun-loving perennial facing due west. After the first hard freeze, it's best to cut it to the ground. With very little care (water), it comes back year after year offering these giant red blossoms. The day lilies on the right are not my favorite, but I always enjoy that one time of

year when they are in full bloom. My preference is with perennials that continually bloom and love Texas heat.

RPENA Entrance Update

I hope you have taken a stroll to the Claymore entrance to check the progress of the new perennial garden. The young plants are loving this rain and are beginning to thrive. I must show my respect to the most loyal, hardy perennial I have used for several years. New Gold Lantana loves to be ignored once established. It requires several hours of sun each day to bloom which makes it perfect for our west-facing entrance to our neighborhood. Lantana comes in other colors, but I have never had



the success with these like I have with the gold variety.

SUMMER REFRESHMENTS

The classic summer margarita!

Hot days call for summer cocktails! Maybe fruity, maybe frozen, and definitely refreshing,



- 1 ounce blanco or silver tequila
- 1 ounce orange liqueur, like Cointreau, Grand Marnier, or Triple Sec
- 1 ounce fresh lime juice, plus lime slices for garnish
- ½ ounce agave nectar or simple syrup, plus more to taste
- Ice
- Lime wedge and coarse salt, for the glass rim (optional)

Instructions

- Salt the rim of the glass (optional):
 Rub a lime wedge around the rim of a rocks glass. Fill a small plate with coarse salt. Dip the glass into the salt to coat the rim. Fill with ice.
- Place the tequila, orange liqueur, lime juice, and agave in a cocktail shaker with ice. Shake and strain into the glass. Taste and stir in more agave nectar, if desired. Garnish with lime slices and serve.

Two trees were planted at the entrance and two large flower beds were created. Crepe Myrtles were planted where Claymore crosses over the creek. Over time, lighting was added to the front



entrance and sprinkler systems were installed. In more recent years surveillance cameras were installed which resulted in our neighborhood being almost completely free of crime while surrounding neighborhoods face crime almost daily. All this of course costs money and the wise homeowners of RPE have generously funded this association of neighbors over the years. The yearly dues are a mere \$ 110/year, less than \$ 10 a month. Last year (2023-2024) more than 80 of your neighbors supported the Richland Park Estates Neighborhood Association, several giving more than the \$ 110. **WE NEED YOU!**
